## Did you know?

- As at 30 September 2022, **94.6%** of all approved and rated services in NSW are rated Meeting or Exceeding NQS in Quality Area 4.

- The highest performing element under Quality Area 4 for all approved services in NSW rated under the 2018 NQS as on 30 September 2022 is **Element 4.1.2**.
- Across all approved services in NSW, **Element 4.1.1 (3.23% Not Met)** under the current 2018 NQS framework is the most significant driver for not meeting NQS in this Quality Area.

## Sector updates

### **New grants to support quality and participation**

Early childhood education and care (ECEC) services across NSW looking to improve their service and encourage more vulnerable children to attend can access our new Quality and Participation Grants program, with applications now open.

The grants are available to community preschools, long day cares, Multifunctional Aboriginal Children's Services, Aboriginal Child and Family Centres and Aboriginal preschools.

Eligible services can apply for a share of \$21 million in funding to assist with increasing access and the participation of children from low-income families, Aboriginal and culturally and linguistically diverse children.

### **2023 Start Strong Program Guidelines**

2023 Start Strong Program Guidelines for Community Preschools and Long Day Care services are now available.

The Program Guidelines cover:

- the purpose of the Start Strong program
- service and child eligibility criteria for Start Strong funding
- Start Strong funding information, spending rules, and other program requirements.

Mobile preschools funded under the Mobile Preschool Funding program are eligible for fee relief payments. The Mobile Preschool Funding program guidelines will be updated shortly to include information on fee relief funding.

We expect funding notification letters will be sent to Approved Providers before the end of Term 4 2022.

#### **Applications for the Crisis Fund, Major Capital Fund and Minor Fund are open!**

Applications for the 2022-23 Start Strong Capital Works [Crisis Fund](#), [Major Capital Fund](#) and [Minor Fund](#) are now open.

A range of [supports](#) are available to assist services in preparing an applications. All applicants for the Crisis Fund and targeted applicants for the Major Capital Fund may be able to [access one-on-one support](#) from industry professionals.

Applications to increase places in areas with a shortfall in community preschool places will be prioritised, but all applicants are encouraged to submit an application if they meet the eligibility requirements.

#### **Crisis Fund**

- The [Crisis Fund](#) is now open until 30 June 2023.
- The extended eligibility includes community preschools, Aboriginal Community-Controlled Organisations and not-for-profit long day care services who deliver a preschool program.

#### **Major Capital Fund**

- The [Major Capital Fund](#) Round one is now open until 14 November 2022 for community preschools only.
- Rounds 2 and 3 will open in 2023 with extended eligibility including community preschools, Aboriginal Community-Controlled Organisations and not-for-profit long day care services who deliver a preschool program.

#### **Minor Fund**

- The [Minor Fund](#) Round one is open now until 4 December 2022 for community preschools only.
- Rounds 2 will open in 2023 with extended eligibility including community preschools, Aboriginal Community-Controlled Organisations and not-for-profit long day care services who deliver a preschool program
